Annual Public Meeting for Inspira Health covering all Inspira Health Medical Centers (Inspira Medical Center Vineland, Inspira Medical Center Mullica Hill, Inspira Medical Center Elmer and Inspira Medical Center Mannington) was held virtually on Wednesday, August 5, 2026, at 4:00pm.
